

## TOXIC DRUG POISONING RESPONSE **PUBLIC REPORT, JANUARY 2022**

## **ILLICIT DRUG TOXICITY DEATHS**

- According to BC Coroners Service, there were 70 illicit drug toxicity deaths in Fraser Health in January 2022 (Table 1).
- This is a 21% increase from the number of deaths reported in the same month last year, with 58 deaths in January 2021.

## PARAMEDIC-ATTENDED TOXIC DRUG POISONING EVENTS

- BC paramedics responded to 813 toxic drug poisoning events across Fraser Health in January 2022 and 863 in December 2021.
- Counts in January 2022 increased by 5% compared to the previous 12 months (Table 2).
